This honor is granted to sworn Iowa peace officers who have been seriously, critically or fatally injured in the line of duty. In addition, this award may be conferred if an injury was averted by body armor.

## PAST RECIPIENTS



**Officer Jill Ohm Fitch**  
**Sioux City Police Department**  
**Date of incident: 10-03-2014**

Officer Jill Ohm Fitch was dispatched to a disturbance involving a subject who was possibly suicidal. A male exited the residence and Officer Fitch initiated contact with him, not knowing if he was involved. This subject was being compliant with Officer Fitch and following verbal directives. Without warning or provocation, the suspect pulled a handgun from his pocket and advanced on Officer Fitch, firing two shots at point blank range. One of the bullets struck her in the chin.



**Sergeant Brendan Zeimet**  
**Maquoketa Police Department**  
**Date of incident: 04-01-2014**

Sergeant Brendan Zeimet was shot and seriously injured during a suspicious person investigation in the early hours of April 1, 2014. While ending his shift just before 3:00 a.m., Sergeant Zeimet observed a truck parked on the wrong side of the road with its lights off and one occupant. When he got out to check on the occupant, the suspect raised an assault rifle and a gunfight ensued.



**Officer Jamie Buenting**  
**Rockwell City Police Department**  
**End of watch: 09-13-13**

Police Officer Jamie Buenting was shot and killed during a standoff in the early hours of September 13, 2014. Officers had responded to a home four hours earlier after receiving a report that a man, wanted for felony domestic assault, was at the location. The man refused to exit the home when officers arrived and barricaded himself inside. The subject fired a single shot at approximately 1:40 a.m. and struck Officer Buenting, killing him.



**Lieutenant Patrick Richardson**  
**Newton Police Department**  
**End of watch: 09-01-2013**

Lieutenant Patrick Richardson went on a run in preparation of the department's mandatory bi-annual physical fitness test. During the run, he developed heavy chest pains and realized he was having a heart attack. He summoned bystanders for assistance and was eventually flown by air ambulance to Iowa Methodist Medical Center where he ultimately passed away.
